This supplement (the “**Supplement**”) to the base prospectus dated 17 September 2019 (the “**Prospectus**”, which definition includes the base prospectus and all information incorporated by reference therein) constitutes a supplementary prospectus for the purposes of Article 23(1) of Regulation (EU) 2017/1129 (the “**Prospectus Regulation**”) and is prepared in connection with the £3,000,000,000 Euro Medium Term Note Programme established by Metro Bank PLC (an “**Issuer**”).

This Supplement is supplemental to, and should be read in conjunction with, the Prospectus and the documents incorporated by reference therein. Capitalised terms used in this Supplement but not defined herein shall have the meanings ascribed to them in the Prospectus.

The purpose of this Supplement is to:

The sub-section entitled “*Ratings*” under the section entitled “*Overview of the Programme*” on page 13 of the Prospectus shall be updated by replacing the first sentence of the first paragraph in its entirety with the following words:

“**As of 2 October 2019, the Issuer Credit Rating assigned to the Issuer by Fitch was BB.**”
