How do I open and manage my account and fees?	 You can apply to open a Trust Bank account if you are 18 years or over, a UK resident and an appointed trustee as set out in the Trust Deed. There is a one-off account opening fee of £150.00. This fee will be taken directly from your Trust Bank Account when there are sufficient funds to cover the account opening fee. You can apply using your professional advisor, directly by contacting the Trust Centre or via any Metro Bank store. Please visit our website for more details - https://www.metrobankonline.co.uk/trustee-banking/ All Keys Account Parties (KAPs) associated with the trust will need to be fully identified You will need to provide a certified copy of the Trust Deed to Metro Bank as part of the account opening process If the trust needs to be registered with Trust Registration Service (TRS) you will need to provide proof of registration There is no maximum balance that can be held in your trust account, please contact us for any requests over £10m. If your Trust Bank Account balance stays above £25,000 for any whole month (or partial month in the month the account is opened), we'll waive the monthly account fee for that month. If the balance falls below £25,000 at the close of business on any day a £5 monthly account fee will apply. You can manage your account in store, through Online Banking or by telephone on 0345 08 08 508. You can close your Trust Bank Account at any time
Can I withdraw money?	 You have unlimited access to your money. You can withdraw up to any amount from your Trust Bank account. For cash withdrawals over £1,000 you must give us one banking weekday's notice and all authorised signatories as per the bank account mandate must be present. You can withdraw funds at any time, either in any Metro Bank store or via telephone or online banking
Additional Information:	 There are 2 options available for online banking in relation to your trust bank account. Please choose your preferred option when you apply for an account or by contacting the Trust Centre Standard Online Banking - Online banking for trust customers with non-complex (1 to sign) mandates up to a daily limit of £21k per day. This service is free of charge. Dual Sign Online Banking - Online banking service for trust customers with complex (2 to sign) mandates allowing 2 signatories jointly to make transactions online up to a daily limit of £250k. This service is charged at £5 per month. This fee is in addition to the £5 monthly fee for falling below the £25,000 threshold. All account signatories must register for online and telephone banking to fully utilise our contact centre Please note, all authorised signatories required to sign as stated on the bank mandate must be registered for telephone banking and need to be contacted every time in order to process an instruction via telephone banking. This account does not offer a debit card or a lending facility but does offer a cheque book. If we are going to deduct a charge mentioned in this document from your account at a future date, we will give you at least 14 days' notice. If your contact details are not up to date, we may charge you any costs involved in trying to find you.
